BALANCE DEADLINE

06 APRIL 2026 – Deadline to send VENDING EXPO SRL the receipt of the BALANCE relating to the assigned exhibition area. (Cap. I Art. 9 del Regolamento Generale)

WITHDRAWAL RULES

Within 07 DECEMBER 2025

If the written cancellation reach the Organizer till 07 DECEMBER 2025 the penalty will be equal to an amount corresponding to the registration fee

From 07 DECEMBER 2025 till 07 MARCH 2026 If the written cancellation reach the Organizer **till 07 MARCH 2026** a penalty equal to an amount corresponding to the advance payment as calculated in the countersigned participation proposal will be applied

Within 10 APRIL 2026

If the written cancellation reach the Organizer **beyond 07 MARCH 2026** and **up to 10 APRIL 2026** a penalty equal to an amount corresponding to the entire amount as quantified in the countersigned participation proposal will be applied

From 11 APRIL 2026

If the written cancellation reach the Organizer from the date of **11 APRIL 2026**, penalty will be equal to on amout corresponding to the entire balance due as determined in the signed exhibiting proposal.
